Corporate Income Tax

Malaysia's economy is based on free enterprise, with no restrictions on foreign ownership of a business. The repatriation of profits and the import of capital are freely allowed. Malaysia has a low corporate tax rate at 17% to 24% compared to other leading economies in the world. A company is taxed at scales rates on its chargeable income, and capital gains are not taxable.

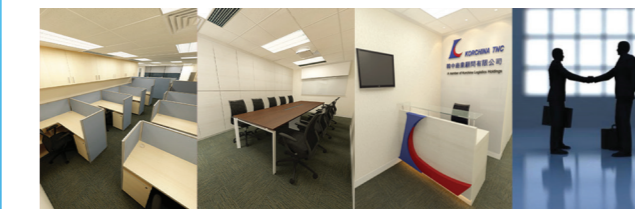
Personal Income Tax

Sole Proprietor, Partnerships and Salaried Employees are liable to pay Individual Tax.

Sales and Services Tax (SST)

Sales tax is a single-stage tax, only imposed at one stage in the supply chain at the import or manufacturers level. Service tax that is a tax charged and levied on taxable services provided by any taxable person in Malaysia in the course and furtherance of business.
