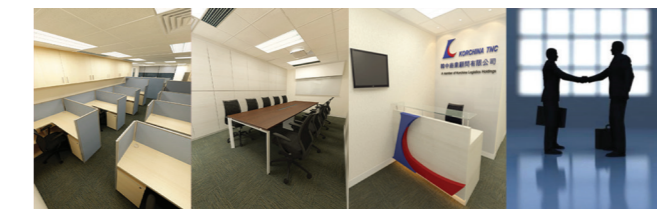
Goods and Services Tax (GST)
